## **BDI—2 Scoring Booklets**

## **IHR Update: Children's Trust Fund Website**

The Institute for Health and Recovery (IHR) wants to be sure that EI staff know about the Children's Trust Fund's site, www.onetoughjob.org. Caregivers and staff can look up resources as wide-ranging as parks, housing, services for domestic violence survivors, WIC, day care, etc. The site provides an online forum for parent discussions. ## **EI Autism Updates**

Over the past few weeks, a number of changes in billing for Autism services have begun to be implemented. As information has become available, the DPH has made every effort to communicate this to the field. Along the way there have been a number of questions and concerns that we have received from both EI providers and Specialty Providers. We are communicating daily with our team at DPH as well as contacts at MassHealth and other insurers, to address concerns and answer questions, to the best of our ability, with the most up to date information we have available to us.

## **Changes to SSP Autism Intake Policy**

Among the many changes with the provision of Specialty Services for children with an ASD diagnosis, the DPH will no longer allow billing for intake visits to be conducted by SSPs, beginning October 1, 2016. Intakes that were conducted after July 1 through September 30 will be billed to DPH using the blended rate for reimbursement.

It is suggested that each EIP collaborate with their respective contracted SSPs to develop a plan to disseminate information to families regarding options for Specialty Service provision, after a child receives a diagnosis of ASD. This should not differ drastically from current program practices of notifying families of their SSP options; it would just not include a face-to-face billable visit from the SSP. Each program should decide what works best in their current model of practice and be fully implementing this by September 30. The DPH will be monitoring data the next few months to insure a smooth transition to this new practice. #### **BDI—2 Video**

All EI programs are required to submit one video of the BDI-2 being administered to a child either referred to, or enrolled in, their Early Intervention program between July 1, 2016-December 31, 2016. This requirement is part of the ongoing implementation of the State Systemic Improvement plan (SSIP) to evaluate our Data Quality strand in our action plan. Each video will be reviewed by DPH staff using the Fidelity Checklist (version 2016) and written feedback will be given to each program. If programs are producing BDI-2 videos of other reasons (part of a technical assistance plan, etc.) during this time period, then that video may be used for this requirement. At this time, the BDI-2 must be administered in English for this requirement. We are investigating options for reviewing Spanish speaking videos, but do not have that resource at this time.

#### BDI-2 video submission instructions:

The purpose of this video is to provide feedback to the EI program in their administration of the evaluation tool (Battelle Developmental Inventory, 2nd edition). The video will focus on the examiner(s) and not the parent or child, however, it is likely, due to the nature of the activity, that the parent or child will be visible in the video. This video will be solely used for General Supervision to the EI program. This means it will be reviewed by appropriate staff at the Department of Public Health/Early Intervention and parts may be used to give feedback to the staff at your EI program. Once this process is completed, the video will be destroyed.

Instructions for videotaping for the fidelity checklist:

- 1. Review and Complete DPH-EITC Consent forms for ALL people who are captured on video.
  - a. Child/Family
  - b. EI providers
  - c. Other

Check off the box:

'to create a **video file or film** and use it for General Supervision of the Early Intervention Program.'
Return all consent forms to DPH

- 2. Videotaping guidelines:
  - a. Video tape without stopping the camera throughout the administration
  - b. The interview is part of the video (or audio).
  - c. Focus the video on the examiner not on the child
  - d. Make sure that the Interviewer is close enough to the device that he/she is heard on the video.
- 3. Video and consent form submission instructions: 2 options
  - a. Submit via Interchange to Noah Feldman at <u>noah.feldman@state.ma.us</u>: this is a secure electronic process (that was used for annual report submission) <u>https://ics.mass.gov/DynIC</u> (see attachment for instructions for use of Interchange) <u>NOTE</u>: programs have had difficulty using this method because of the size of the file.
  - b. Submit directly to DPH staff: save video on a memory stick and deliver directly to a DPH staff member. Please coordinate this process with Noah Feldman, noah.feldman@state.ma.us or (617) 624-5532.

## **Fidelity Checklist**

Many programs have requested a copy of the fidelity checklist. The form itself has not been fully updated to reflect the '2016' changes that are mentioned above, however, the main criteria will not be changing. Here are the headings that we will be looking at for each item:

#### Standardization Errors include:

Examiner or parent cued the child

Examiner did not use the correct verbal prompt

Examiner did not use the correct materials

Examiner allowed additional time or trials for the item

Examiner did not ask one or more of the interview questions

Based on the review of videos from the past 2 fiscal years, there may be some changes to the edits that have not been finalized. More information will be shared as it is available.

The fidelity checklist will be made available to programs once finalized. Please use these criteria as a guide.



## Data Manager Updates

### FY2016 Annual Report and Self-Assessment

#### Timely Services - Which IFSPs to Enter (also sent as an email to EI providers on 8/1/16)

There have been questions from providers regarding which IFSPs to enter and which ones NOT to be entered into the Timely Services Report. The 10 children under this report were chosen



QUESTION: The instructions state that, "The children in this database may have IFSPs that occurred PRIOR to 7/1/15. Do NOT enter those IFSPs into the report. Only enter IFSPs that occurred between 7/1/15 and 6/30/16." Should we enter an IFSP Review if it occurred between 7/1/2016 and 6/30/2016 for an IFSP that was initiated prior to 7/1/2015?

DPH RESPONSE: Yes. For example, a child has an initial IFSP that was signed on 6/5/2015, an IFSP review signed on 12/1/2016 and a subsequent IFSP signed on 6/10/2016. The 12/1/2016 and the 6/10/2016 IFSPs should be entered The 6/5/2015 IFSP should NOT be entered

QUESTION: In the period of time for FY16, a 6 month IFSP review was done with no changes. The re-evaluation was delayed due to the parent canceling it and did not occur until July 2016. So the only information to be entered into the Timely Services report is the IFSP review...Is this correct? You do not want any other reviews or subsequent IFSPs.

**DPH RESPONSE:** Yes, that is correct. The one IFSP Review is all that we are requesting.

QUESTION: I have a child on this report whose last IFSP was signed on 4/1/15 which is before the time frame that we are looking for in this report (IFSP between 7/1/15 and 6/30/16). The service coordinator was not able to contact the family to complete the annual assessment until 7/6/16 and the child turned three on 7/9/16. I don't have an IFSP to enter in this time period and am wondering why this child was selected and how I should proceed.

DPH RESPONSE: The child was selected because they received a full year of services. The child should at least have had an IFSP review during this time period. If that is the only IFSP that occurred for this child then just enter the IFSP review information.
