#### Save the Date: Children's Vision Massachusetts Coalition Summit 2016

The purpose of this <u>Summit</u> is to raise awareness regarding the critical role vision plays in child wellness and education; highlight successful programs and partnerships that improve vision health outcomes for children; and recognize individuals and organizations, who, embracing the important relationship between vision, child development and education, create opportunities for children by improving their ability to see. Speakers include experts in early education, ophthalmology and optometry.

## **NCHAM Hosting Webinar: Risk Monitoring for Delayed-onset Hearing Loss**

On Thursday, July 21st, NCHAM will be hosting the webinar "Risk Monitoring for delayed-onset hearing loss in young children" presented by Jessica Stich-Hennen.

Since the 1970s, Joint Committee on Infant Hearing (JCIH) has recommended audiological monitoring for newborns and young children identified with risk indicators for delayed-onset hearing loss. JCIH 2007 position statement provided guidance on which risk indicators to monitor and which risk indicators should be monitored more frequently. The statement recommended "audiological assessment at least once by 24-30 months of age." Unfortunately, the 2007 JCIH position statement did not provide detailed protocols on how long to monitor, how frequent to monitor and when to discharge children from risk monitoring. As a result, there are inconsistencies in risk monitoring programs from state to state, clinic to clinic, and even audiologist to audiologist.

In Idaho, approximately 50% of infants identified with hearing loss present with risk indicators. At least half of infants with risk indicators and diagnosed hearing loss had more than one risk indicator identified.

This webinar provides current information regarding Idaho's "best practice" protocol for monitoring risk indicators in newborns and young children. The pros and cons of the current risk monitoring protocol will be addressed. It will describe Idaho's classification system for risk monitoring and address risk monitoring data collection procedures in Idaho. Data will be presented on the incidence and prevalence of risk indicators and diagnosed hearing loss in Idaho.

Overall, the presentation describes risk indicators for delayed- onset hearing loss, provides guidance for establishing audiology protocols for risk monitoring and provides guidance for tracking risk indicators at a state level.

Dr. Jessica Stich-Hennen received her Clinical Doctorate in Audiology (Au.D.) from the Idaho State University. In April 2011, she achieved Specialty Certification in Pediatrics from American Board of Audiology. Dr. Stich-Hennen's clinical specialty areas include pediatrics diagnostics and amplification, auditory evoked potentials and auditory processing disorders. She is the primary audiologist for the Idaho Cleft Palate-Craniofacial team.

## Massachusetts Act Early Team Awarded Grant from Association of Maternal & Child Health Programs (AMCHP)

The "Learn the Signs. Act Early." (LTSAE) program provides educational information to parents, health care professionals and early care and education providers about the importance of early identification and intervention for children with signs of autism spectrum disorder and other developmental disabilities (ASD/DD).

Act Early State Systems grants are awarded on a competitive basis to state teams to strengthen their state and community systems for early identification and improve coordination of early intervention services for children with signs of ASD/DD. The State Systems grants are for a two-year period and are designed to increase parent-engaged developmental monitoring by promoting the adoption and integration of LTSAE materials and training resources into programs and statewide systems that serve young children and their families.

A brief description of the Massachusetts' two year project is described below:

Goals: To develop and broadcast a coordinated series of seven cable access television shows and three radio programs to be promoted, aired, and archived on multiple online platforms that will educate families from both mainstream and diverse cultures across the state and region about healthy developmental milestones and what to do about red flags for concerns in young children, with a particular focus on families from racially, culturally, economically and regionally diverse communities.

Year one of the grant will focus on development, review and evaluation of culturally competent content for radio and to shows; recruitment of cable and radio stations, show hosts and panelists; training and rehearsing. Year two will focus on the actual taping of shows and dissemination to families across the state through online downloads and mailings. Translation of written materials in 7 languages will occur across both years of the grant. Data will be collected throughout the process and materials will be widely available to programs. Stay tuned for more details as this project is launched!

Below, you will find information that has been shared with Cohort 1 about the PIWI implementation and the expectations for programs and staff. For those programs NOT in Cohort 1, this is just for your information moving forward. We will share it again prior to the implementation with your cohort.

#### PIWI Program Training: Cohort 1 (sign up dates August—December 2016)

Who needs to attend:

REQUIRED: EI Specialists working 20+ hours and those working less than 20 hours who serve in the role as service coordinator.

RECOMMENDED: All EI Specialists working at the program.

Prerequisites: Overview of the Pyramid Model Framework: On-line module (www.eitrainingcenter.org)

<u>Logistics</u>: PIWI facilitators (2) will train at a location designated by the EI program for their staff. Programs will need to provide:

- Training space for their staff
- Equipment for presentation:
  - Laptop
  - ♦ Projector/Screen
  - Speakers

Programs who do not have access to this equipment must contact Noah Feldman (<a href="mailto:noah.feldman@state.ma.us">noah.feldman@state.ma.us</a>) at the EI Training Center at least 2 weeks prior to their training date to arrange to borrow the equipment.

#### PIWI Coaching (initiated at the program Post Program Training and running through July 2017)

One of the Training Facilitators from the Program Training will serve as your PIWI Coach. The PIWI Coach will meet with the Program PIWI Champions (see below for more detail) to determine an Action Plan [Template provided by DPH] for supporting the use of Triadic Strategies in home visiting for the staff at the program. The PIWI Coach will schedule between 3-6 coaching sessions (90-120 minutes each) with the PIWI Champions to support their ability to coach program staff in using triadic strategies in home visits. PIWI coach activities will include:



- Facilitating discussions with the PIWI Champions on the strengths and challenges within the program with regard to implementing the PIWI
- Determining an action plan with the PIWI Champions to address the challenges [Template will be provided by DPH]

#### PIWI coach activities MAY include:

- Training and activities to support building confidence and competence in the PIWI Champions in supporting the triadic strategies
- One-on-one sessions with the PIWI Champions to support their individual challenges in coaching their program team

#### **PIWI Champions**

Role: The PIWI Champions are designated by the EI Program Director to support the implementation at the EI program. Each EI program is responsible for identifying the number of PIWI champions that can support the implementation of the PIWI program wide. PIWI Champions will be responsible for:

- Participating in the PIWI coaching sessions (see above for more detail)
- Support program staff in implementing the PIWI through the use of triadic strategies during home visits by following the Action Plan developed with the PIWI Coach.
- Observe or review video of staff during home visits and collect data on the number of times they are using triadic strategies: Each PIWI Champion will complete this data collection on at least 4 staff members. 2-3 observations with the same family, observations would be 1 month apart from one another. [Form will be provided by DPH]
- Document coaching or other supporting activities with staff [Form will be provided by DPH]

#### **Staff Responsibilities**

All program staff who attend the PIWI training will be required to use the strategies discussed in their home visits with a parent or caregiver.

#### **PIWI Evaluation**

- 1. PIWI Champions will submit their data collection on the use of triadic strategies (see above for detail). [Form provided by DPH]
- 2. Two volunteer staff from each program to video 3 home visits all with the same family, each 1 month apart. (These videos can also be used by the PIWI champion for their data collection). These videos will be coded for quality characteristics and feedback.
- 3. PIWI Champions will submit their training and support activities (see above for detail) [Form provided by DPH]
- 4. Staff will complete on-line self-assessments (on-line)

NOTE: This is the data collection plan for the first year of implementation. We will be evaluating the effectiveness of this data collection plan and determining the on-going methodology after we complete the implementation plan with the  $1^{st}$  cohort.

#### **Replacement of EI Training Center Competency Certificates**

It is highly recommended that you keep your Certificates from the Early Intervention Training Center in a safe and secure place. You will need them when the time comes to compile your portfolio.

#### **CEIS Portfolio Due Dates**

Any professional working a total of 20 or more hours per week, at one or more MDPH certified in an early intervention program(s), as a staff member, consultant or fee for service employee, is required to complete an application for full certification; and become fully certified within three years of his/her date of hire. The CEIS portfolio is due on the last day of the month corresponding to the month during which you were hired, e.g. if you are hired on August 1, 2016, your portfolio is due on August 31,2019. At your time of hire, you receive a letter from the Department of Public Health advising you of your due date.

For staff whose hours drop to fewer than 20 hours per week, the due date is adjusted: The time period during which your hours are reduced does not count toward your 3 year time frame, i.e. your certification "clock" stops ticking during that time period. If your hours increase again to over 20 hours per week your "clock" begins ticking again. **You are expected to monitor your own hours** to determine your due date. You may need to consult your program's administration or human resources staff to determine exact dates for changes in hours. It is your responsibility to keep track and use this information in determining your due date.

#### **CEIS Manual**

The CEIS manual is posted on the EI Training Center web site at <a href="www.eitrainingcenter.org/pd/?">www.eitrainingcenter.org/pd/?</a> page=certificationrev#2012. In addition to the entire manual, the portfolio cover sheet and the required sections for each entry may be downloaded separately. You may complete forms individually online, download them, and print them prior to submitting your portfolio. Applicants are strongly encouraged to complete the sections online. For staff members who want a printed manual, the Commonwealth of Massachusetts Health Promotion Clearing House will have a repository of manuals that may be ordered by individual programs. Further information regarding the process for ordering manuals from the clearing house will be made available within the next few weeks.



## **FY17 Support for Massachusetts EI Programs for Supervision of Interns**

The EI Training Center at the Massachusetts Department of Public Health is continuing a program to support local Early Intervention sites in hosting interns from Massachusetts Approved Higher Education Programs.

Those programs are:

- Bay Path University: Certificate Program in Early Intervention
- Lesley University: Bachelor's degree programs in Child and Family Studies or Early Childhood Education with an EI Concentration
- Northeastern University: Graduate degree programs in Speech Language Pathology, Counseling Psychology, School Psychology or Physical Therapy with an EI Concentration; Bachelor's degree programs in Communication Disorders and Psychology, both with an EI Concentration; Interdisciplinary Early Intervention Certificate Program
- MGH Institute of Health Professions: Graduate degree program in Speech Language Pathology with an EI Concentration
- UMASS Boston: Bachelor's degree program in Early Education and Care in Inclusive Settings with a concentration in Early Intervention

Internships of at least 300 hours will be supported through this initiative. The hosting Massachusetts EI program will receive \$300 and each site supervisor will receive \$200. NOTE: An EI programs may now apply for support for more than 1 intern per semester. For each additional intern approved, each additional site supervisor can receive the \$200 stipend. Reimbursement will be issued based on successful review and applications are reviewed in order or receipt. Programs may apply for internship support for one student per semester.
