#### **Early Childhood Special Education Transition Forum**

### **DPH Updates:** Implementing the Affordable Care Act in MA: Changes in Subsidized Coverage Programs

The Blue Cross Blue Shield of Massachusetts Foundation is releasing a new issue brief, <u>Implementing the Affordable Care Act in Massachusetts: Changes in Subsidized Coverage Programs</u>. This issue brief, prepared by Health Management Associates, provides a comprehensive review of the changes to subsidized insurance in Massachusetts resulting from the passage of The Patient Protection and Affordable Care Act (ACA). It analyzes the changes in eligibility, benefits, cost sharing (including premiums), and health plan options available to individuals receiving subsidized insurance in the Commonwealth before and after implementation of the ACA.

#### Data Manager Updates: EIIS Upgrade

The next EIIS upgrade will include ICD-10 codes effective for evaluations on or after October 1, 2015. This upgrade is being tested and will be available for installation by providers by the end of October. In order for this upgrade to go smoothly DPH will provide a check list of things that an EI program needs to have in place before installing the new version of EIIS.



#### **New Request for Reimbursement Form**

The Department has updated the Request for Reimbursement form to a PDF form that the EI program can type into, save and SecureMail to Susan Murray for each request for reimbursement. The request form has been tested and is almost ready to be distributed to all EI programs. The Department will be sending out the new form to programs sometime in October.

#### Specialty Services Updates: BCBA Licensure—Changes

A recent change in the BCBA license expiration date has come to our attention at DPH.

In a prior notification to the field, the process of applying for and obtaining a license for BCBAs and BCaBAs was outlined. Originally, according to the Division of Professional Licensure, those obtaining a license prior to October 1, 2015, would receive a license with an expiration date of December 31, 2015, and would then need to renew that license through December 31, 2017, thus having to pay the license fee of \$155 twice. Some in the field had indicated that they would postpone seeking licensure until after October 1 in order to avoid the duplicate fee.

At this time, the Allied Mental Health Board at the Division of Professional Licensure has indicated that a change has been made in this regard. Currently, licenses issued after July 31, 2015 will be valid until December 31, 2017. As previously indicated, the DPH strongly recommends eligible BCBAs and BCaBAs to obtain licensure as soon as possible to avoid any delays with reimbursement for services during this transition. The field will be informed of the deadline date for implementation of this requirement as soon as it is determined.

## The Division for Children and Youth with Special Health Needs (DCYSHN) is looking for your help!

One focus area is the development of a standardized feedback loop documenting the outcome of referrals from the Medical Home/Pediatrician to Early Intervention programs. As a starting point, DCYSHN is interested in seeing any templates that EI programs use to "close the loop" with referring pediatricians. We would appreciate it if programs would share these forms with the DCYSHN. Thank you to programs that have already provided their materials in response to a request from a Regional Consultation Program and thanks in advance to any other programs willing to share their forms.

#### **NCSEAM Family Survey Update**



The next dissemination of the NCSEAM Family Survey will be in October. Surveys were shipped to all programs on August 19. Please let the Department know if you did not receive your Surveys.

The number of Surveys sent to each program was based on EIIS data through June of 2015, with an additional 10% added to that number. This is to ensure that programs will have enough Surveys for both the **October 2015** and **March 2016** distributions. Please remember that the shipment you received in August is for the entire year and put the Surveys to be used in March in a safe place. We will have a small number of additional Surveys here at DPH but rely on programs to safely store the ones

they get initially.

A list of children whose families should receive a NCSEAM Survey will be sent to all programs by the third week in September. These will be families whose children have been enrolled in EI for at least **six** months who did not complete a Family Survey in March 2015. # Neuropsychology of Alcohol and Substance Abuse Disorders: Neurotoxic Sequelae in Infants, Children and Adults

This presentation differentiates "classic" Fetal Alcohol Syndrome from the more underidentified Fetal Drug and Alcohol Exposure disorders. These conditions create increased risk for "subtle" and worse neurodevelopmental disorders (in learning, attention, memory and Executive Functioning.) This Webinar focuses on applying knowledge of Clinical Neuropsychology to evaluations of brain impairment in young and older children with histories of Fetal Drug/Alcohol Exposure and on differential diagnosis of frontotemporal disorders in adolescent alcohol/substance abusers (neurotoxic effects on the physiologically immature brain.) The adult neurotoxicology component to this webinar addresses the misdiagnosis of DSM-5: Bipolar and Mood Disorders for Substance Induced Mood and Cognitive disturbances that "mimic" these other psychiatric conditions. The presentation concludes with patient education methods to enhance recovery of function in affected clients.

#### Learning Objectives:

- \* Develop a basic understanding of the under identified neuropsychological consequences of fetal drug and alcohol exposure as differentiated from the predominant medical model that is limited to diagnosis only of Fetal Alcohol Syndrome. Overlooked conditions include "acquired" neurocognitive disorders
- \* Learn about an evaluation model that identifies neurotoxic effects on learning, attention, memory and executive function in young and older children with histories of Fetal Drug/Alcohol Disorders and differentiating frontotemporal disorders due to adolescent alcohol/substance abuse effects on the "physiologically immature" brain
- \* Understand how neuropsychological assessments of adults with alcohol and substance abuse can differentiate "overdiagnosed" Bipolar and Mood Disorders from underdiagnosed Substance Induced Mood and Cognitive disturbances. This area of focus will also include how to enhance prognosis for recovery of function.

#### Presenter Biography

Dr. James Lewis is a Clinical Neuropsychologist with over 35 years of experience conducting child and adult evaluations in child abuse and neglect cases. His clinical and teaching experience includes a focus on neurotoxicology of Fetal Drug and Alcohol Exposure, impaired neuropsychological development in child and adolescent alcohol and substance abuse disorders. Dr. Lewis' continuing professional seminars also include applying neuropsychological evaluation methods to "co-occurring" mental health and alcohol/substance abuse disorders in adult caregivers. Dr. Lewis has lectured extensively on drug and alcohol related neurodevelopmental disorders, especially as applied to the Child Welfare System.

### EITC Updates: EI—Newborn Behavioral Observation Study

The Brazelton Institute has received funding from the Noonan Foundation to conduct an Early Intervention-Newborn Behavioral Observation study (EI-NBO). The study is a year-long project that examines the effectiveness of an EI-NBO model of care on infant and maternal outcomes.

Project investigators have received interest in participating from some Massachusetts Early Intervention providers. They would like to confirm that those providers are still interested in participating, and would also like to open the opportunity to other programs. EI programs need participation of about 5-6 individual EI Specialists - 3 NBO trained and 3 usual care providers.

If programs have staff members who are interested in participating, but have NOT been NBO trained, there is an upcoming EI NBO training on Oct 15th and 16th. More information can be found at <a href="https://www.brazelton-institute.com/clnbas.html">www.brazelton-institute.com/clnbas.html</a>

By participating in the study, EI NBO providers will receive:

- 1) 3-day advanced NBO training with study investigators from the Brazelton Institute. The cost of attending and travel to the training will be covered. This offering will be a 3 day training, scheduled in early December. More details will be available soon.

#### **CEIS Process Support**

Early Intervention Training Center staff wants to remind you that there is online support for applicants and supervisors working on preparing portfolio submissions for the Certification Process (CEIS).

Certification for Early Intervention Specialists – 2012 How to complete a CEIS Portfolio in 3 years:

This module summarizes the process of completing an application for certification as a Massachusetts Early Intervention Specialist. It provides an overview and suggestions for identifying supports that are available to the applicant in completing the process and also provides a time line to guide its completion in a three year time frame.

**The Role of the Supervisor in the CEIS 2012 Portfolio Process**: This module summarizes the role of supervisors in supporting individuals during the process of completing an application for certification as a Massachusetts Early Intervention Specialist. The module will provide an overview of supervisory roles and responsibilities in assisting CEIS candidates and a time frame that can be used as a guide.

#### **UMass Boston: BDI—2 Fidelity Study Update**

UMASS has completed the coding process for the study. They have reviewed the submitted videos and are currently working on feedback for each program. They will be sending feedback as they complete each video between now and January 2016. Feedback will initially be sent to Noah in a sealed envelope and Noah will forward the sealed envelope out to the appropriate program contact. DPH staff will not see the individual program results, only the aggregate results. Feedback must come through Noah because videos were coded when submitted to UMASS Boston so that they did not know the program identity.
