#### **Family TIES Director, Pat Cameron**

Pat also worked on the staff of the Governor's Commission on Mental Retardation. Pat is the parent of two adult children; her 35 year old daughter, Beth, has Down syndrome as well as hearing and vision challenges.

#### **BDI—2 Video Submission Information (FY19)**

Video submissions are being accepted **now**, through **Friday**, **September 6**, **2019** (deadline). Early submissions are welcomed and appreciated!

#### **DPH EI Web-based System Update**

Detailed information for the activities scheduled for Tuesday, February 26, 2019:

- **1. DPH Webinar**: The regular DPH webinar will be from 9:30-10:30am (time change see email dated 1/25/19). This webinar will offer a Demonstration of the developing EI Client System. We welcome you to invite anyone in your agency/program to tune in to the webinar and see the system. SSG will walk us through the parts of the system that are available for viewing.
- 2. Web-based System Stakeholder meeting: The Stakeholder meeting will begin at 9:30am and at that time we will be showing the Client System demonstration/webinar as part of the meeting. Representatives from SSG (IT vendor) will be present at the Stakeholder meeting. There will be time for questions both in person and for those participating in the webinar. The SSG component of the meeting will be offered concurrently through the webinar. A full agenda with times will be sent about 1 week prior to the meeting.
- 3. **User experience testing**: This activity will happen at SSG in Needham. The purpose of this is to have actual users of the system try out the developed pages and forms to give feedback to SSG about the ease of use.

This is a lot to have occurring in one day. Given our resources and timelines, this is the most efficient way to get all of the work done, that needs to be done, in order to deliver the Client System on time.

We know that you are waiting for more information from DPH about implementation, support to programs, responses to individual agency questions, and requirements for upload...this will be coming soon! We are working hard to get information out to you!
