## **PIWI/Reflective Supervision PILOT opportunity ANNOUNCEMENT**

The Department of Public Health is excited to share they will be bringing together two of our initiatives over the next year. We will be connecting Reflective Supervision with PIWI implementation.

Based on the feedback from the SSIP Stakeholders, information from the ICC Program Planning, supervision supports and data from the Reflective Supervision Pilot, a PIWI/Reflective Supervision Pilot has been created.

The purpose of this PIWI/Reflective Supervision Pilot will be:

- 1. To determine the impact of Reflective Supervision on the implementation of PIWI at early intervention programs
- 2. To evaluate the impact of the Reflective Supervision training on supervisors and supervisees activities.
- 3. To inform DPH on the need for program support for supervision.

This is a unique opportunity for supervisors to attend the Reflective Supervision Training this fall and continue to practice reflective supervision with additional activities from January 2020 to July 2020. The requirements:

- The supervisor completes all requirements of the DPH Reflective Supervision Training that are being offered in Taunton and Marlborough.
- The supervisor will be required to provide Reflective Supervision at least twice monthly for the 6 months to staff that will be observed for PIWI data collection. (more information to come on PIWI observations for 2020)
- The supervisor and supervisee must have completed either PIWI training at their EI program (EITC facilitated) or Foundations of MA EI, part 2: PIWI to participate in this pilot.

As part of the pilot, the DPH will provide reimbursement to the program for the Reflective Supervision sessions. (HV rate for 12 - 60 minute supervision meetings).

There is limited space in the pilot and programs will be required to submit an application to DPH to participate. Applications will be available in the next few days and will be sent out to Program Directors as soon as it is available. Programs who already have an Individual registered for the Reflective Supervision training can apply for this pilot.

# Specialty Services Update

## Specialty Services Information Now Available on State Website!

Over the past several months, the DPH Division of EI has been working on transferring information and materials to the state website at <a href="mass.gov/dph/earlyintervention">mass.gov/dph/earlyintervention</a>.

Now, Early Intervention Specialty Services information and resources are readily available. The mass.gov search engine will quickly bring you to the Specialty Services landing page where you can find individual tabs to Vision, Hearing, Autism Spectrum Disorder and Regional Consultation Programs. Within each section is a Table of Contents with sections that include service description, provider directory, provider documents (\*Starting Points for Service Coordinators\*) and links to state or national resources.

Autism Spectrum Disorder provider documents have additional materials such as the Reimbursement Policy Manual, and the Referral, Notification, and Service Request forms used by EI programs to communicate with SSPs for Autism about referral and insurance authorization details.

Check out the related resources tab for quick links to other services and supports offered by other state agencies that can be shared with families receiving Specialty Services.

\*Starting Points for Service Coordinators\* documents were created by the ICC Specialty Subcommittee for each of the low incidence conditions eligible for Specialty Services. Each easy to read one-page document follows the same format and should be part of any packet of information as a resource to your staff working with any of the low incidence conditions. Starting Points goes through the Referral Process, First Steps and Resources that can be shared with families. These step by step guides will help new service coordinators and seasoned staff alike to address the unique needs of the child with a low incidence condition.
