Professional Development for EI Providers Updates

The Department of Public is offering an online training series of professional development over the summer. There will be several training topics offered to support the early intervention field.

Live-Online Trainings

Massachusetts Mission and Key Principle Training: "What it Looks Like and Doesn't Look Like"

This online training will increase your knowledge of the 7 Key Principles for the Massachusetts Early Intervention System. The training will demonstrate what the key principles look like and don't look like in practice. You will also gain knowledge and access to resources that will help you as you support and partner with families in Early Intervention. The training was developed by an international workgroup that formed out of the Early Intervention-Early Childhood Professional Development Community of Practice. Members of the workgroup have extensive experience developing and delivering Early Intervention training. This training is one part of a Universal Online Part C Early Intervention Curriculum that may be used to support quality Early Intervention practices and has been modified from its original version to reflect the Massachusetts El curriculum. This training will be offered two times and will consist of 2 trainings; a Part 1 and Part 2. Each training will be 2 hours long and limited to 25 participants to encourage discussion.

An Introduction to the Early Intervention Client System (EICS) for Clinicians

The training is an alternative way to support EI Specialists in learning the EI Client System. Using the resources induded in the Grab & Go: An Introduction to the Early Intervention Client System (EICS) for Clinicians, we will provide a facilitated presentation that gives an overview of the EI Client System, identifies and explains key terms and will begin to lead an EI Specialist through the steps of completing the data entry process from referral to discharge.

There will be no additional information shared than what is offered through the online Grab & Go resources. Instead, this may be a good alternative for learners who require a more facilitated presentation style by a member(s) of the Regional Specialist team. There will be an opportunity to review needed topics in more depth and have questions answered.

We will be offering this live training at 3 different days/times in June to help keep the participants low and encourage discussion. It is expected these will last no more than 2 hours.

Coffee Chats

We will also be offering other live training opportunities regarding the EICS that are shorter and topic specific – Coffee Chats. After a clinician has gone through the Introduction to the Early Intervention Client System, in whichever modality is best suited to their learning style, they are invited to take part in these additional one-hour topic trainings. Our first "Coffee Chat" will be specific to completing Progress Notes within EICS.

Coffee Chats

EICS- Completing Progress Notes

The training will explain the components of the completing a progress note in the Early Intervention Client System. It will be interactive and allow time to ask questions. You must be familiar with the EICS prior to registering for this Coffee Chat. This training will be an hour long.
