## <u>DPH Updates</u>

## EI Client System

We appreciate all the work the field is currently doing at the program level training staff to get ready for the R-2 implementation. The R-2 implementation deadline has been extended to 12/31/20. Starting on that date, all programs will be required to ensure that all the R-1 and R-2 data requirements are being entered into the system. If data is not entered, the EI program will be at risk for having claims to DPH denied and will be out of compliance for data entry requirements. Just a reminder, the DPH EI Client System R-2 functionality continues to be available for programs to use now in the Sandbox and live system. Below is a list of the supports available to programs to support their planning and implementation of R-2.

#### Supports Available:

- The EICS Sandbox is still available to explore.
- The El Client System user manual is available in the Help section of the Sandbox and Live system
- Agency Calls to discuss your R2 implementation plan can be scheduled by contacting your Regional Specialist. This
  allows you to organize your thoughts, create a timeline and customize a roll out that is individualized to your agency/program.

#### EI Client System trainings have been developed:

- ♦ An Introduction to the Early Intervention Client System (EICS) for Clinicians- Grab and Go PowerPoint training: This training could be used in whole or in part and broken up in sections for staff to be trained internally at programs. Please connect with your Regional Specialist on other ideas of how it could be used.
- ♦ An Introduction to the Early Intervention Client System (EICS) for Clinicians Live training opportunities. The training is the same training that was created from the Grab and Go and its purpose is to have another modality to learn the material. It is an opportunity for a staff member to attend the training and see how they could use the materials themselves back at the program to train their staff.
- EI Client System (EICS) Sandbox Scenarios Self-paced Learning Activity
- A self-paced learning activity that walks an EI clinician through each step to complete different scenarios of building a child within the EI Sandbox. This gives steps of what to do and what the results will be after each step so you know if you are on the right track. This helps different learning styles who do well with reinforcement and structure.
- ◆ Transition Crosswalk: A crosswalk of transition requirements in the EI Operational Standards to the EI Client System.
- EICS Coffee Chats: The Coffee Chats are a chance to focus more on a specific task within the EICS and ask questions.
  - ♦ Progress Notes
  - ♦ IFSP
  - ♦ Transition & Discharge

EI Regional Specialists are available to schedule an R-2 agency call to plan implementation as well as discuss any EI Client System questions you may have.

I have found the system to be very easy to use if you follow the guidelines of the IFSP process. #### **DPH/EI Orientation FY2021**

The Department of Public Health is offering Institute trainings for supervisors and PIWI champions this fall.

#### **Reflective Supervision Institute**

**The Reflective Supervision Institute** is a 3- day virtual Institute to learn and practice the elements of Reflective Supervision (RS). \* must be a supervisor to attend this institute

#### Learning Objectives

- Plan for successful supervision with supervises.
- Develop relationship with supervisor/supervisee which promoted the relationship between both the provider and the parent and the parent and the child.
- Learn ways to use RS during observations to support functional assessment and PIWI philosophy.
- Explore the barriers to providing RS and generate plans to overcome those barriers.

#### **PIWI Learning Institute**

**The PIWI Institute** is a 4- day virtual training that will provide an overview of Parents Interacting With Infants (PIWI) model, the "why" behind PIWI, strategies for successful implementation, and opportunities to problem-solve challenging situations. \* must be a supervisor or a PIWI champion to attend this institute

#### Learning Objectives

- Apply the use of dyadic and triadic strategies to support parent/child interactions and profess toward achieving IFSP outcomes.
- Differentiate how each discipline in El can support and promote PIWI using their individual experiences.
- Demonstrate how functional assessment supports PIWI in Massachusetts EI home visiting.

## **Supporting Materials for Programs and Requirements for Attending Live Trainings:**

- These 6 trainings are all the components that would be found in Foundations 1 and Foundations 2.
- There will also be 6 Grab and Go's with the same material as the live trainings.
- The Grab and Go's' will be available for program directors and supervisors to use to support their staff with the curriculum.
- We often hear from programs that they don't remember the material that is being trained to new staff. Now all programs will have access to the material.
- However, the new program staff for FY 21 will be required to attend the live online trainings as part of DPH orientation.
- Supervisors of staff attending the trainings will be expected to attend a monthly Community of Practice (COP) for 3 months while their supervisees are registered for the above trainings.
- The COP are one time a month for 2.5 hours for supervisors.
